OFFICIAL RULES

East Los Angeles Mexican Independence Day Parade



1. All participants must be uniformed, Mexican costumed and appropriately attired.
2. Political, or social advertising will be Prohibited, Anybody who disobeys will be disqualified immediately.
3. All entries must be approved by the Parade Committee. Any deviation from these rules must be approved during the time of application.
4. Marching bands are allowed up to 20 persons. (Except School Marching Bands, Charros, or folklore groups).
5. The Parade Committee will not be responsible for false statements made by applicants.
6. **FORWARD** motion must be maintained when passing in front of the TV cameras and throughout the parade route. (Violations subject to disqualification).
7. Children under 8 years are not permitted to march, due to the extreme heat.
8. Check-in closing time **10:15am**. All participants will be in their position by 10:30am. (Otherwise CMCP is not responsible for your position in the parade **line up**).
9. **Prohibited to hand out or throw anything along the parade route**
10. NO fireworks, sirens, or loud noises that interfere with other entries.
11. Participants must remain inside their respective vehicles during the entire parade route.
12. **PROHIBITED** drinking alcohol before or during the parade. Anybody who disobeys will be removed from the parade immediately.
13. Line up formation will be on a first come first serve basis with the application and payment.
14. **Payment must be received by Tuesday August 15th 2011** participant failure to pay in a timely manner will not be allowed to participate. (No exceptions).
15. All Entries must be decorated in a Mexican theme.
16. Equestrian and motorized entries must have proof of insurance submitted with application.
17. In closed vehicles are prohibited. (Violations subject to disqualification).
18. CMCP is not responsible or subject to any liability for any entries that are not part of the local TV broadcast for the parade.
19. Parade entries may not approach or have any direct contact with the crowd at any moment.
